# 5. Demolition Works Project

# 5.1. Environmental approval conditions

NSW Trade & Investment updated the meeting on:

The engagement of NSW Public Works to complete the Plan of Management for the Large-eared Pied

Crown Lands are currently processing the covenant over Lot 68/752200 and Tunnel 1, 2 & 3. The completion of 1 of 22 approval conditions.

### 5.2. Camera

NSW Trade & Investment and NSW Public Works updated the meeting on the installation of a camera on-site. This camera will be able to be access via a link on the Woodsreef web page. The Taskforce noted to the Community Representatives that this camera will assist the community in watching the demolition of the mill and silo, whilst removing them from the risks associated with attending the mine

#### 5.3. Schedule

NSW Trade & Investment, NSW Public Works, Delta Group and Parsons Brinkerhoff updated the meeting on the following:

- Delta has engaged 2 structural engineers.
- Parsons Brinkerhoff has commenced the occupational air monitoring
- The ecologist has cleared the building
- project schedule
  - 0 Milestone 1 - WorkCover NSW Approvals - completed.
  - Milestone 2 Safety documentation and ecologist clearance on schedule 0
  - Milestone 3 Demolition of Mill and Silos pre work has commenced 0
  - Milestone 4 Removal from Site not commenced

The Community Representatives requested Delta and Parsons Brinkerhoff air monitor in Glen Riddle, as this property has permanent residence and is close to the mine. Parsons Brinkerhoff was reminded that the air monitors positioned in paddocks with cattle were at their own risk.

Action: Parsons Brinkerhoff is to relocate an air monitor to Glen Riddle.

Action: The Chair is to send the Community Representatives the air monitoring results.

Action: The Chair is to send the Community Representatives the make and model of the shearing equipment.

Action: The Chair is to remind the ecologist when entering freehold property to contact the owner each and every time.

# 6. Air Monitoring and Health Risk Assessment Project

#### 6.1. Task 2 Hazard Identification

The Taskforce informed the Community Representatives of the Hazard Assessment Report was nearing completion. The Community Representatives expressed their concern and frustration of the delay in the release of the report, an email from Ben Burgess to Paula McIver was tabled and answered. The Taskforce explained that this report isn't a stand-alone document and is the first part of the whole story. The Hazard Assessment Report is the first report in a sweet of 6 reports. The final report will guide the NSW Government with the long term management of the Woodsreef Mine.

## 6.2. Task 3.1 Health Impact Assessment – Prior to the demolition works

The Community Representatives expressed their concern with the delay in releasing the results from the air monitoring that was conducted in November and December 2013. The Taskforce noted that this round of air monitoring was to gather background data. The Taskforce explained the scope of works for Task 3.1 Health Impact Assessment included feedback to the Demolition Contractor on their independent Air Monitoring and Asbestos Control Plan. Parsons Brinkerhoff/Delta has scheduled these plans for delivery by Friday 24 October 2014.

#### 6.3. Task 3.2 Health Impact Assessment – During demolition works

NSW Trade & Investment updated the meeting on the air monitoring schedule and receptor locations for during the demolition works. The following locations will be air monitored every 12 days for 12 rounds commencing 20 October 2014:

- Mr Burgess Property
- Picnic Site on Bundarra Road
- Camping area north of the Mine
- Woodsreef township
- Wynaroy
- **Boxpark Station**
- Barraba Primary School

The Community Representatives request the metrological data and observations be recorded at each sample location and round.

The Taskforce updated the Community Representatives that there will be another round of activitybased air monitoring. This will be conducted outside the demolition period and in the next hot and dry climatic conditions. Activities to be undertaken will include camping, fishing, fossicking and bird watching and/or bushwalking.
